WHEREAS the Petitioner above named through its Advocate Sri A Veeraswamy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ or Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents 1 to 5 in restricting the mining area of the petitioner by 20 hectares out of the original leased out area of 60.704 hectares as per G.O.Ms.No.121, Industries and Commerce (M.III) Department dated 07.04.2005 and permitting the 6<sup>th</sup> respondent to excavate Quartzite ore from the said 20 hectares of land is illegal, unjust, unlawful and is unsustainable or alternatively direct the respondents 1 to 5 to extend a similar relief of rectification of the petitioner's lease sketch configuration of the mining lease G.O.Ms No.121 dt. 7.4.2005 by including the areas of 20 hectares of the contiguous land in Sy.No.33 of Lolugu Village, Panduru Mandal, Srikakulam District with all consequential benefits.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri A Veeraswamy, Advocate for the Petitioner and GP for Mines & Geology for Respondent Nos.1 to 5, directed issue of notice to the Respondent No.6 herein to show cause as to why this WRIT PETITION should not be admitted.

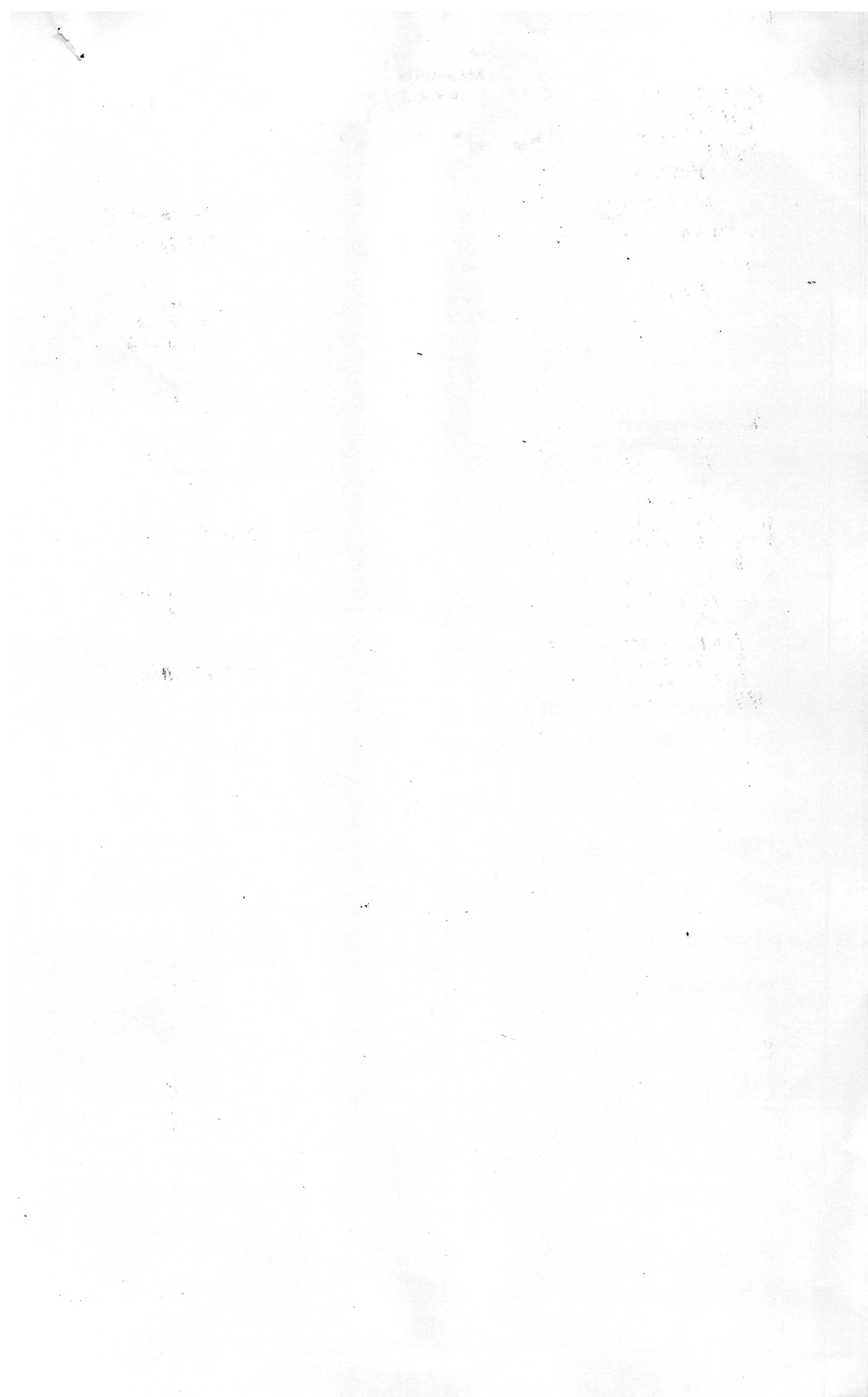
