ORDER:

The present petitioners are arrayed as accused Nos.2 to 5 in C.C.No.719 of 2025 on the file of Judicial First Class Magistrate, Madakasira, Sri Sathya Sai District.

Learned counsel for the petitioner submits that the present petitioners are in-laws of Accused No.1 allegations against petitioners are omnibus in nature, she prayed to quash.

The learned Assistant Public Prosecutor submits that though the allegations against present petitioners are general and omnibus, the matter is pending before learned Trial Court.

Having heard the learned counsel for the parties and upon considering the entire aspect, it appears that there is prima facie justification to entertain the present Criminal Petition. Accordingly, the present Criminal Petition is admitted.

Issue notice upon Respondent No.1.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.1 and file proof to that effect.
