The Court made the following: ORDER

The instant Criminal Petition is filed for quashing a proceeding being C.C.No.4238 of 2025 on the file of the learned VI Additional Junior Civil Judge at Guntur, Guntur District. The present petitioners are arrayed as accused Nos.2 and 3 before the learned Magistrate in the proceedings.

The learned counsel for the petitioners submits that the petitioners/A2 and A3 are the mother and father of accused No.1. The allegations in the FIR are false and omnibus, thus the case in C.C.No.4238 of 2025 on the file of the learned VI Additional Junior Civil Judge at Guntur is liable to be quashed.

The learned Assistant Public Prosecutor submits that there are specific allegations against the petitioners, the investigating officer, after conducting the investigation, submitted the charge sheet against the present petitioners.

Having heard the learned counsels for parties, I find materials to entertain the present Criminal Petition. Accordingly, the present Criminal Petition is admitted.

Issue notice upon respondent No.2.

The learned counsel for the Petitioners is permitted to take out personal notice on Respondent No.2 and file proof of service to that effect.
