Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to suspend the operation of the impugned mutation effected by the 4<sup>th</sup> Respondent on 16.04.2026, insofar as it relates to Sy.No.1539/5B admeasuring Ac.1.11 cents of Anakapalli North-II Village, whereby the revenue records, both online (WebLand/Bhudhaar portal) and offline (Adangal/Pahani), were altered by entering the name of the 7<sup>th</sup> Respondent i.e., "Doori Kamamma Choultry (Endowments Department)" in place of the petitioners' predecessor, Pending disposal of WP No.11385 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). The Court made the following

**ORDER:**

**“Heard the learned counsel for the petitioners and the learned Government Pleader and learned Standing Counsel for the respondents.**

**The petitioners herein filed W.P.No.10148 of 2026, wherein after hearing the matter, this Court passed an order dated 16.04.2026, which is extracted hereunder:**

**“Therefore, this Court is of the considered opinion that this Writ Petition can be disposed of with a direction to the 4<sup>th</sup> Respondent herein to consider the explanation and documents if any, submitted by the petitioners pursuant to the notice dated 24.03.2026 after affording an opportunity of hearing to the petitioner and 6<sup>th</sup> respondent herein and other stakeholders, if any, at the earliest and to pass speaking orders. Till the completion of the entire exercise, the Respondent Nos.4 to 6 are hereby restrained from interfering with the subject property of the petitioners or taking any coercive steps against them.”**

**In view of the violation of the order dated 16.04.2026 of this Court, there shall be an interim suspension as prayed for.**

**Learned Government Pleader and the learned Standing Counsel are directed to inform the order of this Court to the respondents.”**

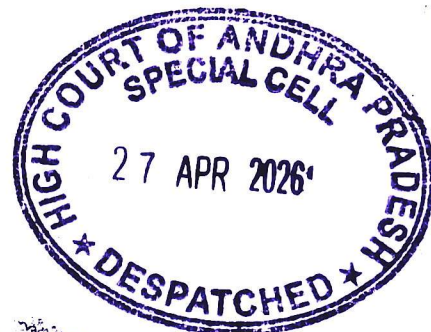
