ORDER:

Heard the learned counsel for the petitioner and the Assistant Public Prosecutor appearing for the State.

The learned counsel for the petitioner submits that the petitioner is arraigned as Accused No.4 in C.C. No.413 of 2023 on the file of the Judicial Magistrate of First Class, Nandalur, for the alleged offences under Sections 417, 498-A r/w 34 of IPC and Sections 3 and 4 of Dowry Prohibition Act.

It is submitted that there are no specific allegations against the petitioner, who is the parent or relative.

Considering the submissions, there shall be a stay of appearance of the petitioner/ Accused No.4 in C.C.
