Petition under Section 528 of BNSS., is filed praying that in the circumstances stated in the grounds filed in support of the CriminalPetition, the High Court may be pleased to grant stay of all further proceedings in C.C No. 70 of 2026 in Crime No. 119 of 2025 on the file on the file of Judicial Magistrate of First Class (Mobile Court), Anantapur pending disposal of the above Crl.P. in the interest of Justice.

The Court made the following ORDER:

Heard learned counsel for Petitioner and learned Assistant Public Prosecutor.

Issue notice to the Respondent No.2.

The learned Counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

Considering the facts and circumstances of the case, the matter is referred to mediation.



Sri Venkata Rao Chalamalasetty, learned trained mediator is appointed as mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The Petitioner and Respondent No.2 shall appear before the mediator on 08.05.2026, or on any other date convenient to both parties and the mediator, and shall co-operate with the mediation.

The learned Magistrate of the Trial Court and the Station House Officer concerned are hereby directed to drive the parties before the learned trained mediator for amicable settlement.

Post the matter after Summer Vacation-2026, for the Mediator's report.

Until the mediation proceedings are concluded, the presence of the Petitioner is dispensed with before the learned Trial Court unless his presence is otherwise required.

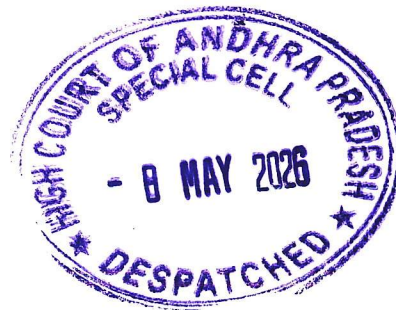
