**ORDER:**

Heard the learned counsel for the petitioner and the learned Assistant Public Prosecutor.

Issue notice to the respondent No.2.

The learned counsel for the petitioner is permitted to take out personal notice on the respondent No.2 and file proof to that effect.

The order dated 30.12.2025 passed by the learned Judge, Additional Family Court-Cum-XIV Additional District and Sessions Judge, Vijayawada, in CrI.M.P.No.608 of 2024 in F.C.O.P(M.C).No.187 of 2023 is stayed, subject to the petitioner paying 50% of the maintenance awarded by the learned Trial Court and also clearing the 50% of the arrears, if any, within a period of four (04) weeks from the date of receipt of the copy of this order.

On failure to deposit the arrears of maintenance within the above-stipulated period, the learned Trial Court shall take appropriate steps for recovery of the said amount.

On such deposit, the respondent No.2 is at liberty to withdraw the same by producing sufficient surety to the satisfaction of the learned Trial Court concerned.

Post the matter after Summer Vacation-2026.
