Petition Under Section 438(1) of BNSS/ Under Section 397(1) of Crpc., is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to enlarge the petitioner on bail by suspending the judgment of the Judge, the Family Court-Cum-IV Additional District and Sessions Judge, Kurnool in CrI. Appeal No..59/2022 dt.10.04.2026 (Accused serviced copy Dis No.208/10-04-2026) in confirming the Judgment in

the Court of Judicial magistrate of First Class Kurnool, passed in C.C No.1116/2018 dated.24.06.2022, Pending disposal of CRLRC No. 466 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case). The Court made the following

ORDER

“The present interlocutory application was filed under Section 438 (1) of BNSS, 2023 by the petitioner to suspend the conviction and sentence dated 24.06.2022 passed in C.C.No.1116/2018 on the file of learned Judicial Magistrate of First Class, Kurnool, which was confirmed vide Judgement dated 10.04.2026 passed in Crl.A.No.59 of 2022 on the file of learned IV Additional District & Sessions Judge, Kurnool District and enlarge the petitioner/accused on bail, pending disposal of the main Criminal revision case.

Heard the learned counsel for the petitioner and the learned Assistant Public Prosecutor on behalf of the State.

In view of the submissions made, the sentence of imprisonment alone is suspended, pending disposal of the Criminal Revision Case on the following conditions:

i. The petitioner herein is directed to surrender before the learned learned Judicial Magistrate of First Class, Kurnool, within one week from this day and, on such surrender, the petitioner shall be enlarged on bail on executing a personal bond for a sum of Rs.20,000/- (Rupees Twenty Thousand only) with two sureties for a like sum each to the satisfaction of the learned Judicial Magistrate of First Class, Kurnool, on the same day.

ii. The petitioner shall deposit 50% of the cheque amount before the learned Judicial Magistrate of First Class, Kurnool, within a period of two (2) weeks from this day. In default of deposit of cheque amount, as

ordered supra, the interim suspension granted today, shall stand cancelled automatically without further reference to the Court.

iii. The petitioner shall appear before this Court as and when directed."

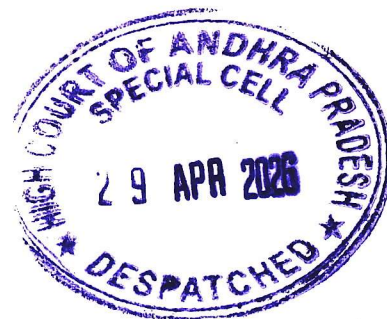
