The Court made the following order:

“The Petitioners are arrayed as Accused Nos. 1 & 2 in C.C.No.315 of 2026 on the file of the learned II Additional Judicial First Class Magistrate, Tadepalligudem, for the alleged offences punishable under Sections 329(4) and 351(2) of the Bharatiya Nyaya Sanhita, 2023¹.

It is the contention of the learned counsel for the Petitioners that the contents of the written complaint are false and concocted, and that the Petitioners have been falsely implicated in this case. Therefore, this Calendar Case is liable to be quashed.
