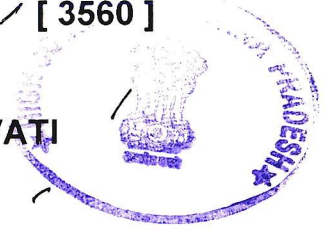

are be and hereby directed to show cause either appearing in person or through an Advocate, as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this **CRIMINAL PETITION** should not be admitted on or before 15.06.2026 to which date the case stands posted for hearing.

The Court made the following: ORDER

“The Petitioner is arrayed as Accused in Cr.No.35 of 2026 of Mahila Urban Police Station, Guntur District, for the alleged offence punishable under Section 85 of the Bharatiya Nyaya Sanhita, 2023¹ .

It is the contention of the Petitioner he never marry Respondent No.2 but only permitted her along with her mother to stay on the second floor of his house. However, disputes arose between the Petitioner and Respondent No.2, and consequently, the Petitioner left his house. The learned counsel further submits that Respondent No.2 had earlier lodged a complaint, which itself falsifies the present complaint.

The learned Assistant Public Prosecutor submits that the investigation is still in progress.

Heard the learned counsel for the parties. This matter cannot be disposed of without hearing the de-facto complainant.

Issue notice to Respondent No. 2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No. 2 and file proof thereof in the Registry.
