ORDER

This is an application seeking stay of all proceedings against Petitioner/Accused No.4 in C.C. No. 871 of 2021 the on the file of the learned Judicial Magistrate of First Class, Palasa, including the requirement of presence of the Petitioner before the learned Trial Court.

Having considered the facts and circumstances of the case, and in view of the fact that the Petitioner is not the signatory of the disputed cheque, this Court is of the opinion that the presence of the Petitioner is not necessary pending disposal of C.C. No. 871 of 2021 before the learned Judicial Magistrate of First Class, Palasa.

Accordingly, the appearance of the Petitioner before the learned Trial Court C.C.No.871 of 2021 before the learned Judicial Magistrate of First Class, Palasa is dispensed with.

It is made clear that, the Petitioner shall be represented through his counsel before the learned Trial Court and shall make his presence only when specifically required, by learned Trial Court including dates of framing of charge, examination under Section 313 Cr.P.C., and on the date of judgment.
