The Court made the following: ORDER

The Petitioner is arrayed as Accused No.4 in C.C. No. 871 of 2021 on the file of the learned Judicial Magistrate of First Class, Palasa, for the alleged offence punishable under Section 138 of the Negotiable Instruments Act, 1881.

It is the contention of the Petitioner that he has been cited as Accused No.4 in the said case, as he is not the signatory of the disputed cheque and is only a partner of the firm. He further submits that he had no role in the issuance of the cheque forming the basis of the complaint.

Heard the learned counsel for the parties.

This matter cannot be disposed of without hearing the de-facto complainant.

Issue notice to Respondent No.2.

The learned counsel for the Petitioner is permitted to take out notice on Respondent No.2 and file proof thereof in the Registry.
