CRIMINAL PETITION NO: 3585/2026

ORDER:

1. The petitioners seek for quashment of F.I.R. being F.I.R. No.144 of 2025 dt.22.07.2025 of Vinukonda Police Station, Palnadu District, registered for the offences punishable under Sections 85, 115(2), 351(2) read with 3(5) of B.N.S and Sections 3 & 4 of Dowry Prohibition Act. The petitioners are arrayed as A.4 and A.5.
2. During the course of hearing, learned Assistant Public Prosecutor submits that after completion of investigation, police has submitted charge sheet in F.I.R. No.144 of 2025 and the same is awaited for numbering.
3. In pursuance of the recent developments, it appears, the petitioner may challenge the charge sheet, if so advised.
4. Accordingly, instant criminal petition is disposed of as withdrawn granting liberty to the petitioner to seek necessary relief according to law.
5. Miscellaneous applications, if any, pending in this criminal petition shall stand closed.
