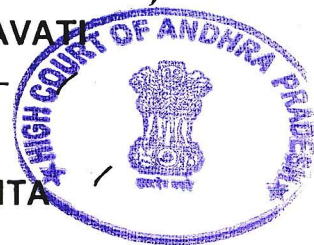

Thus, in this juncture, the investigating officer shall proceed with the investigation according to law, but no coercive steps shall be taken against the petitioners till further orders.

Learned counsel for the petitioners is permitted to take out personal notice upon the 2nd respondent/ de-facto complainant through registered post with acknowledgment due and file proof of service in the registry after summer vacation 2026.
