Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly one in the nature of mandamus, directing the 3rd respondent to conduct and to complete forthwith, the inam enquiry taken-up in Case – IDT.No.143/2012, in relation to an extent of ac.7.32 cts of land pertaining to the petitioner, situated in Sy.No.246 of Tiruchanur Village, Tirupathi Rural Mandal, Chittoor District;
