Petition under Article 227 of the Constitution of India, is filed being aggrieved by action of the Learned Agent to the Government in straightaway

posting the suit in O.S. NO.1/2021/F2 on the file of Additional Agent to Government, K.R. Puram, Eluru District, for judgment without conducting a proper trial in violation of mandatory procedure prescribed under AP Agency Rules, 1924

Petition under Section 151 CPC., is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all further proceedings, including pronouncement of judgment in O.S. No. 01/2021/F2 on the file of Additional Agent to Government & Project Officer, I.T.D.A., K.R. Puram, Eluru District, pending disposal of the main C.R.P.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Ms. NIMMAGADDA REVATHI, Advocate for the Petitioners;

The Court made the following ORDER:

The learned counsel for the petitioner is permitted to take out personal notice to the respondents(s) through RPAD and file proof of service before the registry.

The Civil Revision Petition is filed aggrieved by the action of the learned Agent to the Government in straightaway posting the suit in O.S.No. 1/2021/F2 on the file of the Additional Agent to Government, K.R. Puram, Eluru District, for judgment without conducting a proper trial, allegedly in violation of the mandatory procedure prescribed under the A.P. Agency Rules, 1924.

The contention of the petitioner is that, while entertaining the suit filed by the respondents in O.S.No.1 of 2021/F2, the learned Agent deviated from the procedure contemplated under Rule 15 of the A.P. Agency Rules, 1924, which provides that, except where otherwise

provided under the Rules, the trial of civil suits shall be conducted by receiving written statements and, when the parties are at issue on questions of law or fact, the Court shall proceed to determine such issues by recording evidence, examining witnesses, and thereafter pronouncing judgment.

However, in the present case, the notices issued to the petitioners disclose that the Court has not followed the procedure contemplated under the said Rules before posting the matter for judgment.

Considering the same, there shall be stay of all further proceedings, including pronouncement of judgment in O.S.No.1 of 2021/F2 on the file of the Additional Agent to Government and Project Officer, I.T.D.A., K.R. Puram, Eluru District.

List the matter after summer vacation, 2026.
