No. 579/2022 on the file of the Judicial Magistrate of First Class, Jangareddigudem, and quash the same insofar as it relates to the Petitioner/Accused No.2, as false, baseless, and constituting an abuse of the process of law,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri

KARTHIKSIDDARTHA SALADI Advocate for the Petitioner, Public Prosecutor for R1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

Petition under Section 528 of BNSS is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant a stay of all further proceedings, including the appearance of the Petitioners/Accused No.2, in C.C. NO. 579/2022 on the file of the Judicial Magistrate of First Class, Jangareddigudem, pending disposal of CRLP No. 3699 of 2026, on the file of the High Court.

Heard learned counsel for the Petitioner and the learned Assistant Public Prosecutor.

Issue notice to the respondent No.2.

The learned counsel for the Petitioner is permitted to take out personal notice on Respondent No.2 and file proof to that effect.

At the time of the alleged offence, the Petitioner was 19 years old. It is submitted by learned counsel for the petitioner that the husband of Respondent No.2 killed the mother of the Petitioner, which offence was registered as Crime No. 58 of 2018. The charge sheet was filed in that case, and it is pending before the learned Sessions Judge as S.C.No.181 of 2018. IN the instant crime i.e., Crime No. 59 of 2018 of Jangareddigudem Police Station, the Petitioner/Accused No.2/Jail Praveen, was referred as L.W.2 by the Sub-Inspector of Police

Jangareddigudem, by examining his statement recorded under Section 161 of the 'the Cr.P.C.,' on 05.12.2018.

Having regard to the facts and circumstances of the case, there shall be a stay of all further proceedings in C.C.No.579 of 2022 on the file of the learned Judicial Magistrate of First Class, Jangareddigudem, until the next date of hearing.
