ORDER:

The present Contempt Case has been filed alleging wilful and deliberate violation of the interim orders dated 29.03.2016 passed in W.P.M.P. No. 12838 of 2016 in W.P. No. 10182 of 2016.

2. When the matter is taken up for hearing, there is no representation on behalf of the petitioners.

Sri Venkata Rama Rao Kota, learned counsel for APSPDCL, appearing for the respondents, submitted that the main writ petition was disposed of on 25.04.2025 and that the petitioners herein were promoted as Assistant Divisional Engineers *vide* orders in T.O.O. No.19 dated 08.02.2017 itself. Hence, the interim orders dated 29.03.2016 made in W.P.M.P. No.12838 of 2016 in W.P. No.10182 of 2016 have been complied with. Therefore, the present contempt case may be closed.

4. Recording the submissions made by the learned counsel for the respondents, the present Contempt Case stands closed. There shall be no order as to costs.
