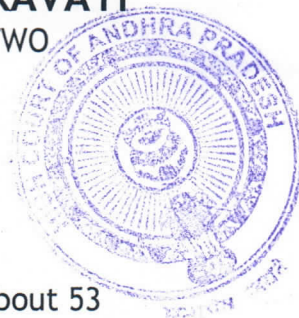

In view of the same, there shall be an interim direction to the respondents to maintain Status quo with regard to the properties to an extent of Ac.7.68 cents of land and buildings constructed therein including staff pending further orders."
