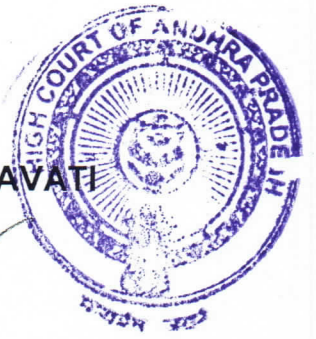

ORDER:

“At the last time of hearing, this Court had directed the appellant to place on record the number of working hours of teaching assistants, who were appointed on tenure basis and the lecturers who were appointed on full time basis and also to submit details of such administrative work that are performed by the full time lecturers and which are not assigned to part time or guest lecturers or teaching assistants.

Again today, time is sought for furnishing such a simple clarification. Hence, hearing is adjourned by two weeks subject to the Registrar, Sri Krishnadevaraya University, paying costs of ₹5,000/- to the account of the Member Secretary, A.P. State Legal Services Authority and the amount shall be paid out of his own pocket.
