WHEREAS the Petitioner above named through her Advocate Sri K Asad Ahamed presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of MANDAMUS declaring the proceedings of the 2nd respondent issued in No. RC/ENC/K3(1)/30022/1998, dt. 27.10.2022 refusing to grant terminal benefits of late D.Ramachandra Raju, DEE (Retired) as illegal, arbitrary and consequentially direct the 2nd respondent to release due provisional pension to an extent of 75percent sanctioned in G.O.Rt.No.885, IAD (Services - I, II) Department, dt. 19.06.2006 as per the orders of APAT passed in O.A.No.5667/2006 in the interest of justice.

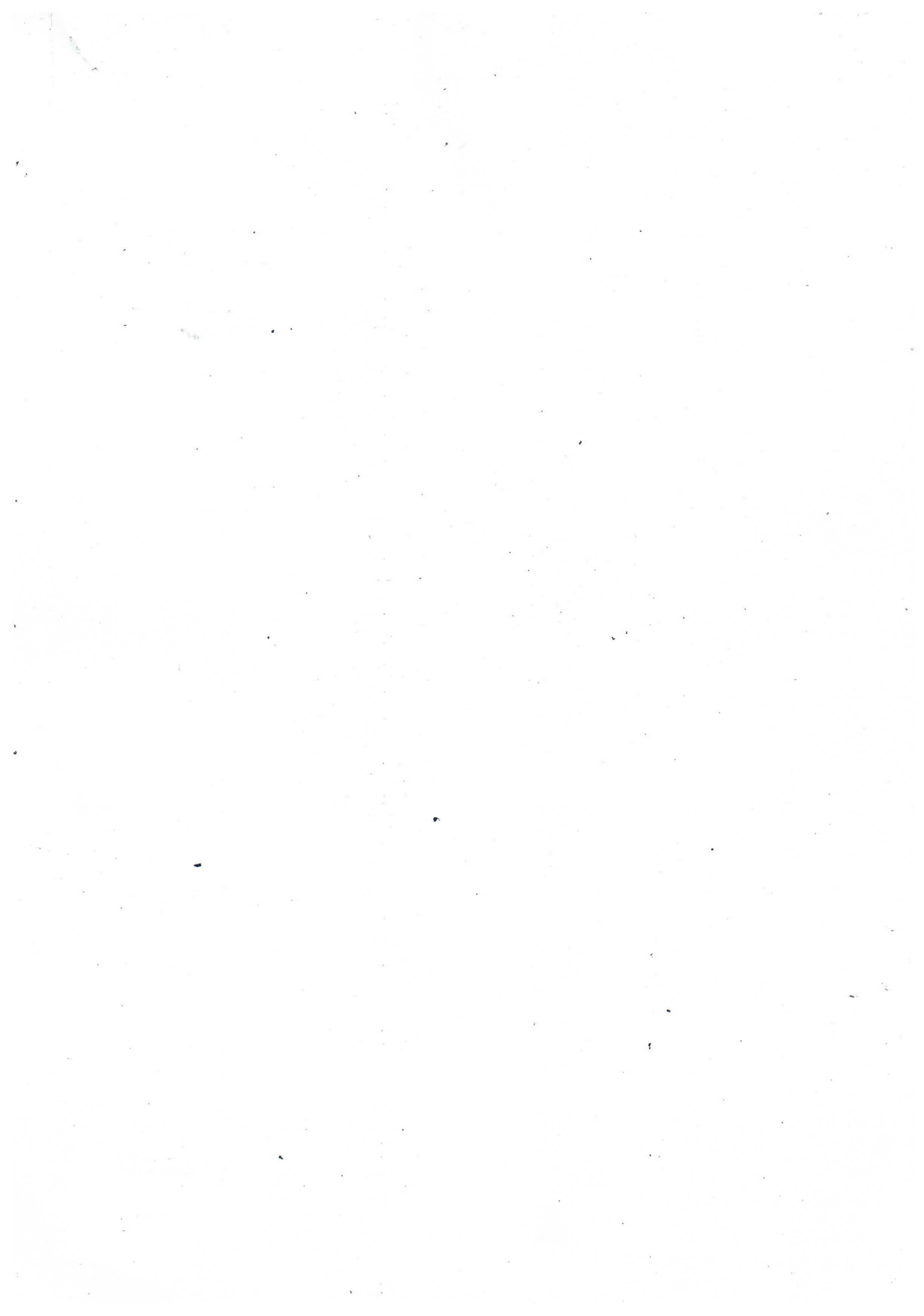
