Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may bePleased to issue a Writ, order or direction more particularly one in the nature of WR/I OF MAIVDAMUS declaringthe Order Dt.16.05.2024 passed in RC.No.528/2022/SA passed by 6th respondent and consequential action of 6th respondent in insisting me to Vacate from my land of Ac 4.75 Cents in R.S.No.469/1 of Makkinavarigudem Revenue Village in T. NarasapuramMandal of Eluru District as illegal, irrational, irregular, without jurisdiction and violative of principles of Natural Justice, provisions of Andhra Pradesh Rights in Land and Pattadar Pass Books Act,1971 and offends articles 14,21 and 300A of Constitution of India and consequential direct the respondents not to interfere in any manner with my possession over my said land.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased may be pleased to suspend the operation of order Dt.16.05.2024 in RC.No.527/2022/SA passed by the 6th respondent and consequently direct the respondents not to interfere in any manner with my possession over my agriculture landed property of Ac. 4.75 cents in R.S.No:469/1 of Makkinavarigudem Revenue Village in T.NarsapuramMandal of Eluru District, pending disposal of WP No. 12164 of 2024, on the file of the High Court.

Petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the earlier order of the High Courtdt 13.05.2024 & 02.07.2024 made herein and upon hearing the arguments of Sri SITA RAM CHAPARLA Advocate for the Petitioner, and of GP FOR REVENUE, for the Respondent Nos.1 to 6 and 8, the Court made the following

ORDER:

“Heard Sri Juvvina Nookapathi Rao, Learned Counsel appearing on behalf of Sri Sita Ram Chaparla, Learned Counsel for the Writ Petitioner and Sri K. Arjun Chowdhary, Learned Assistant Government Pleader for Revenue appearing for the Respondent Nos.1 to 6 & 8.

2. It transpires from the record that the Notice was issued to Unofficial Respondent No.7 on 30.05.2024. The Notice issued by this Court stood served on the Unofficial Respondent No.7 on 03.06.2024. Despite the fact that the Notice has been received by the Unofficial Respondent No.7 on 03.06.2024, there is no appearance either in-person or through any Counsel for Respondent No.7.

3. Accordingly, Respondent No.7 is set ex parte.

4. Let Counter Affidavit be filed by the Official Respondent Nos.1 to 6 & 8 within three weeks. One week thereafter for filing Re-joinder, if any.

5. List the matter on 23.08.2024.

6. Interim Order granted on 30.05.2024 shall stand extended till the next listing.
