WHEREAS the Petitioner above named through their Advocate VARA LAKSHMI CHEKURI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the inaction of Respondents specifically on the part of 5th Respondent in not registering an FIR upon Petitioners complaint, despite disclosure of cognizable offence and further action of 5th Respondent in interfering in civil disputes insisting me to abide the terms of Respondent No. 6 to 10, as illegal, irregular, irrational and without any recourse of law and non-discharge of statutory obligation conferred upon him, and violative of Article 14, 21 of the Constitution of India, and consequently direct the Respondents specifically the 5th Respondent to enquire and register the crime against Respondent No. 6 to 10 in pursuance to said complaint, restraining the 5th Respondent from ever interfering with Petitioners personal life and liberty except in accordance with law, and pass
