WHEREAS the Petitioner above named through his Advocate SRI HARINATH REDDY SOMAGUTTA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more in the nature of Writ of Mandamus by declaring the impugned proceedings vide Rc.No.A1/3824/366/2019 Dated 24.04.2023 on the file of the 4th respondent whereas issued as consequential to the un served Government Memo No.1104666/Ser.III/A1/2020, Dt.28.02.2023 of 1st respondent, whereby rejected the claim of the petitioner for protection of seniority in the cadre of Junior Assistant by counting the service rendered by the petitioner as AR police constable i.e. from 22.07.1992 to 2003 and accordingly not considering notional promotion of the petitioner on par with his juniors in the promotional cadres of Senior Assistant and Office Superintendent as highly illegal, arbitrary, contrary to the As per Section 47 of Persons With Disability Act, against the Law laid down in W.P. No.40730 of 2002 by the Hon'ble Madras High court and against the judgment of Apex court rendered in Appeal (civil) 1789 of 2000 dated.13.02.2003 and set aside the same and consequently direct the respondents to protect the seniority of the petitioner in the post of Junior Assistant by counting the past service rendered as AR police constable and as per the same extend the notional seniority on par with the juniors with all consequential benefits

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri HARINATH REDDY SOMAGUTTA Advocate for the Petitioner, GP FOR SERVICES-I, for the Respondent Nos.1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

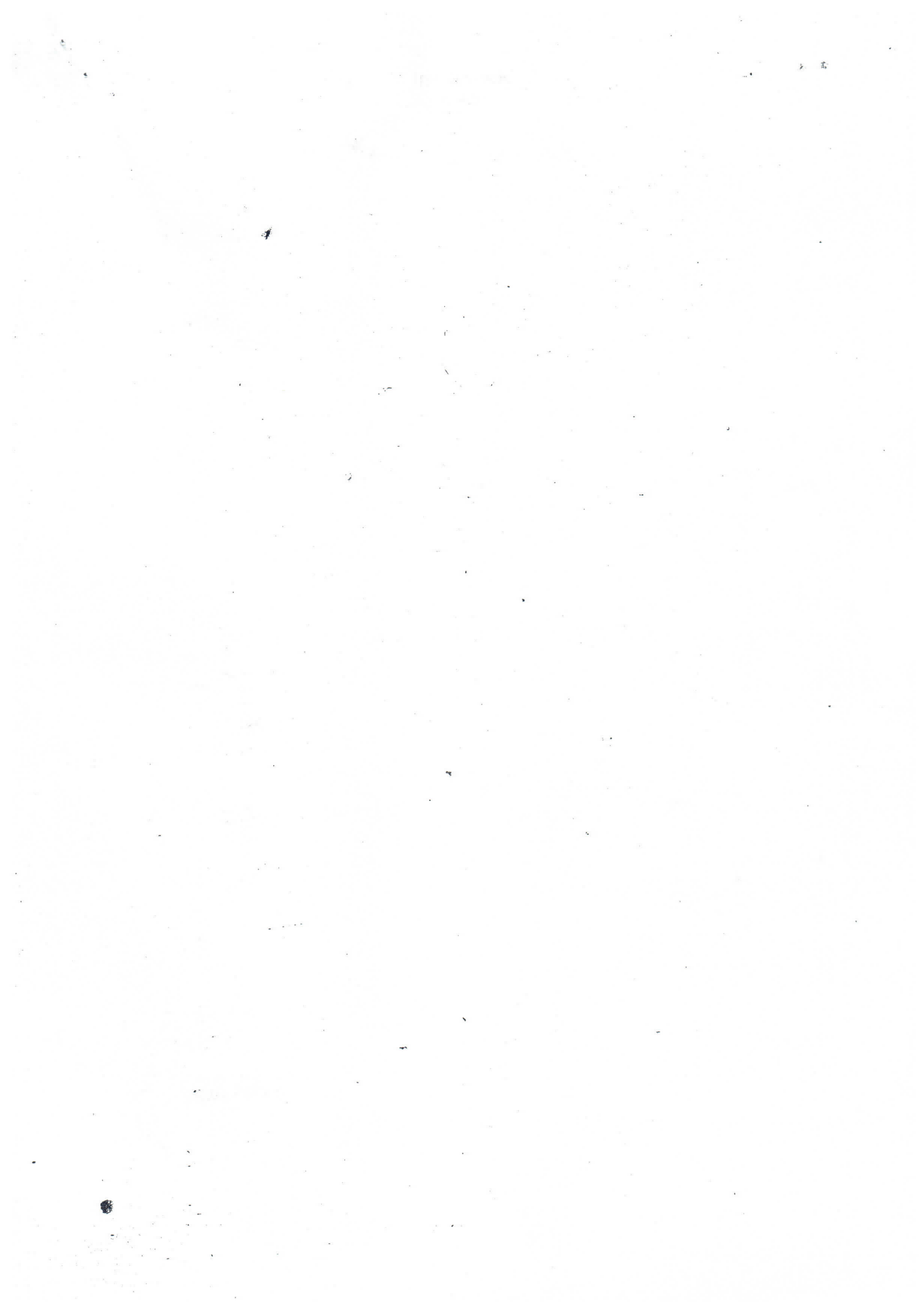
