Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not paying the admitted gross amounts of Rs. 7,55,071/- (Rupees Seven Lakhs Fifty Five Thousand and Seventy One Only) due to the petitioner as per the Agreement vide No.48/2018-19, dated 25.05.2018 as illegal arbitrary, contrary to the principles of natural justice and in violation of the Art 14, 19 and 21 of the Constitution of India and consequently direct the respondents to make the payment of an amount of Rs. 7,55,071-00 forthwith along with an interest of 24percent p.a and pass

ORDER :

1. Heard Sri Shaik Mohammed Ismail, learned counsel for the Writ Petitioner and Ms.M.Sandhya Deepthi, learned Assistant Government Pleader for Agriculture.
2. Learned Government Pleader for Agriculture would submit that there is no dispute about the quantum of claim made by the petitioner and requests four (4) weeks time to clear the bills.
3. Having regard to the above submissions, directed the respondents to pay the claim amount i.e., Rs.7,55,071/- to the petitioner, as per the Agreement No.48/2018-19, dated 25.05.2028 regarding construction of Veterinary Dispensary with Compound Wall at Palugurallapalli village of B.Mattam Mandal, within four (4) weeks from the date of receipt of a copy of this order.
4. With the above directions, the present Writ Petition is disposed of.

Interim orders granted earlier if any, stand vacated.
Miscellaneous petitions pending if any, stand closed.
