**Since the alleged offences punishable below seven years and compoundable in nature, the matter is referred to mediation.**

**Mr. V.S.A Ramamurthy Pusuluri, learned trained Mediator, is appointed as the Mediator in this case.**

**The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.**

**The fee for the Mediator shall be fixed at a later point of time.**

**The Petitioners and Respondent No.2 are directed to appear before the learned Mediator for amicable settlement.**

**The learned Magistrate of the Trial Court and the Station House Officer concerned are hereby directed to drive the parties before the learned trained mediator.**

**The presence of the petitioners No.2 to 4 is dispensed with in C.C.No.69 of 2026 on the file of learned Principal Civil Judge (Junior Division) –cum- Judicial Magistrate of First Class, Bhimavaram, unless their presence is specifically required.**

**Post the matter after Summer Vacation-2026, for Mediator's report.**
