Mr. Venkata Rao Chalamasetty, learned trained Mediator, is appointed as the Mediator in this case.

The Secretary, High Court Legal Services Committee, is directed to issue necessary proceedings in that regard.

The fee for the Mediator shall be fixed at a later point of time.

The Petitioners and Respondent No.2 are directed to appear before the learned Mediator for amicable settlement.

The learned Magistrate of the Trial Court and the Station House Officer concerned are hereby directed to drive the parties before the learned trained mediator.

Post the matter after Summer Vacation-2026, for Mediator's report, along with Crl.P.No.4003 of 2026."
