Petitioner above named through his Advocate SRI S V MUNI REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Certiorari declaring the impugned Proceedings of the 1st respondent in Revision Petition No. 22022-182-2016-Lands-VI, dated 09.06.2021, confirming the proceedings No. D. Dis.No.E1/1230/2016, dated 10.10.2016 of the Joint Collector, Nellore, 2nd respondent, and the proceedings No. D. Dis (J)/1870/2005, dated 01.02.2016 of the Revenue Divisional Officer, Nellore, 3rd respondent, and also the Proceedings No.Rc.B.4851/2010, dated 16.04.2015 of the Tahsildar, Nellore, 4th respondent, as illegal, unjust, arbitrary, contrary to law, void. malafide, violative of the provisions of Andhra Pradesh Assigned Lands (Prohibition of Transfers) Act and the amended Act No.21 of 2008 and to quash the same by calling for the records, Revision Petition No. 22022-182-2016-Lands-VI, on the file of the 1st respondent, and consequently the respondents be directed not to interfere or dispossess the petitioner in respect of the lands, admeasuring Ac.3-14 cents in Sy.No.86/1B, Ac.1.96 cents in Sy.No.87/3, totaling Ac.5.10 cents of Ambapuram Village, Nellore (Rural) Mandal, SPSR Nellore District.

Dis.J 1870/2015, dated 16.04.2015 in Rc.B.4851/2010, including the dispossession of the petitioner from the lands, admeasuring Ac.3-14 cents in Sy.No.86/1B, Ac.1.96 cents in Sy.No.87/3 of Ambapuram Village, Nellore Rural Mandal, SPSR Nellore District, pending disposal of WP 14988 of 2021, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and the order of the High Court order dated 30.07.2021 made herein and upon hearing the arguments of Sri S V MUNI REDDY Advocate for the Petitioners, and of GP FOR REVEUE for Respondent Nos.1 to 4, the Court made the following.

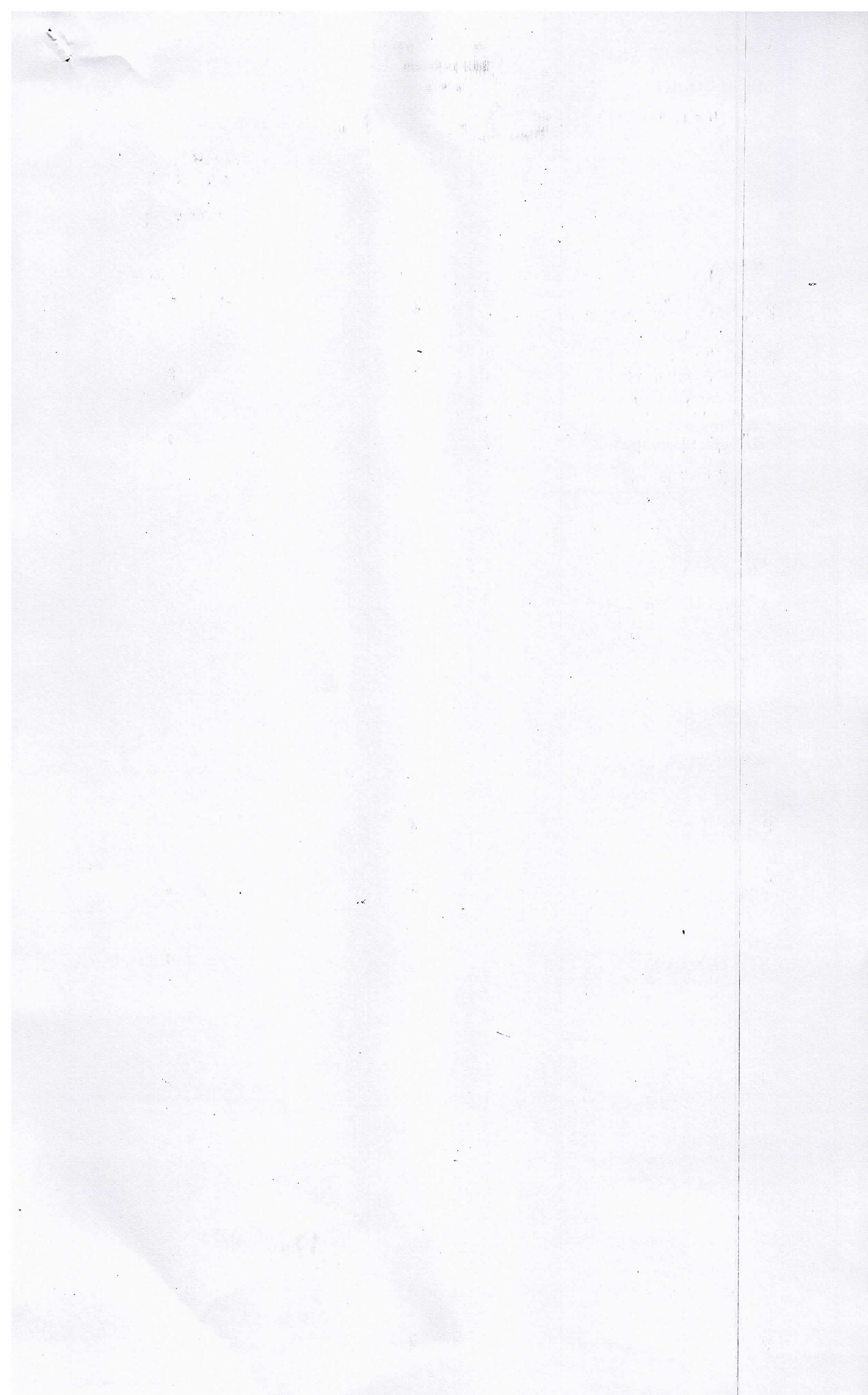
