

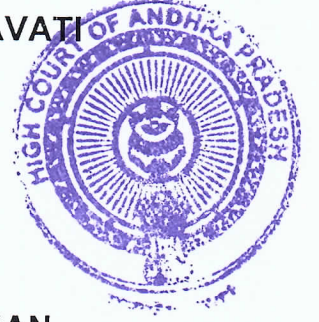

WHEREAS the Petitioners above named through their Advocate SRI GORLE GOPALAKRISHNA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ, Order or Orders, Direction or Directions to declare the action of the 2nd respondent in issuing the Circular.Memo.No.GAD01-SU0MISC/31/2019-SU-I, Dt 21.07.2020 in violation to the Judgement of the Hon'ble Supreme court in S.L.P.(Civil) No. 10349 of 2018, Dt 20.03.2018 and the division bench of the this Hon'ble court in W.A.No. 318 of 2016 and batch Dt 11.11.2016 in surrendering the Network Arogya Mitras to the 5th Respondent Andhra Pradesh Corporation as illegal, arbitrary unconstitutional and to issue consequential direction to the respondents to continue the petitioners, as the employees of the 4th respondent Dr. N.T.R.Vaidya Seva Trust as Network Arogya Mithras in their respective posts .

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri GORLE

GOPALAKRISHNA Advocate for the Petitioners, and of GP FOR SERVICES-I, for the Respondent Nos.1 to 3 & 6, and of SRI K.BHIMA RAO, Standing Counsel for the Respondent No.5, directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to surrender the petitioners to any private employment Agencies by continuing them as the employees of the 4th respondent Dr. N.T.R.Vaidya Seva Trust as Netv/ork Arogya Mithras in their respective posts, pending disposal of WP No. 12692 of 2025, on the file of the High Court.

The Court made the following: ORDER

Learned Government Pleader for Services-I takes notice for respondent Nos.1 to 3 and 6.

Sri K.Bhima Rao, learned Standing Counsel takes notice for respondent No.5.

Issue notice to respondent No.4.

Learned counsel for the petitioner is permitted to takeout personal notice to respondent No.4 through registered post with acknowledgment due and file proof of service in the Registry.

The petitioners are stated to be working with respondent No.4 and continuing as such even as on today, now they are proposed to be migrated to respondent No.5 against their wish.

The petitioners challenge the circular dated 21.07.2020 by which general directions were issued to migrate all the persons who have been working on outsourcing basis to respondent No.5. Petitioners have filed Ex.P-6 to show that they are continuing with respondent No.4 even as on today.

In view of the same, respondents are directed to maintain *status quo* with respect to their continuation in service with respondent No.4 for a period of eight (08) weeks.
