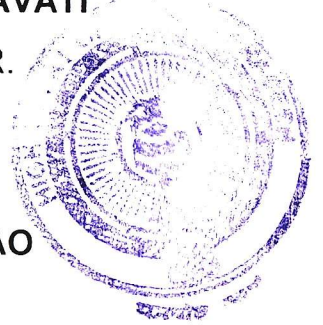

Smt Koppaka Aruna, learned counsel is appointed as learned Mediator in this case.

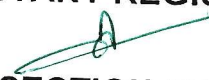
The Secretary High Court Legal Service Committee is directed to issue necessary proceedings in that regard.
