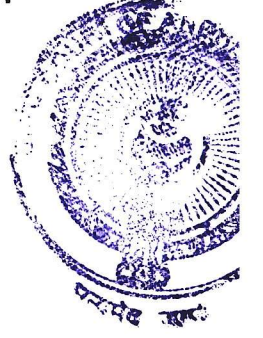

Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an Writ order or direction more particularly one in the nature of Writ of Mandamus declaring action of the 4th respondent Special Cadre Deputy Registrar, District Cooperative Officer, Anakapalli District,

issued the Proceeding in Rc.No 181/2025-C (Coop) Dated 02-05-2025 without jurisdiction, and also as per G.O.Ms No 34 , Food and Agriculture (Co-op).IV) dated 18- 01-1989 and section 116-C of A.P.C.S Act 1964 as illegal arbitrary and violation of Articles 14, 21 of the constitution of India and Principle of Natural Justice and consequently Set aside the Proceeding in Rc.No 181/2025-C (Coop) Dated 02-05-2025 issued by the 4th respondent society.
