WHEREAS the Petitioners above named through their Advocate Sri K.JYOTHI PRASAD presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction on the part of the 2nd respondent in respect of

consideration of representations dated 01/03/2024 and 18/06/2024 by proceeding with the approval of the Layout File No. 1013/0002/LP/KAD/2024 submitted by the 4th respondent herein by showing the Private Property of the petitioners situated in an extent of Ac.0.35 Cents covered by Survey No.703/1B of Mamillapalli, C K Dinne Mandal, YSR Kadapa District as access/approach road to his land proposed for Layout covered by Survey Numbers 701-1 AND 701-2 of Mamillapalli, C K Dinne Mandal, YSR Kadapa District and in allowing the 4th respondent to lay access/approach road high handedly through the private property of the petitioners as detailed above as illegal, arbitrary, malafide, against the provisions of the Act and in violation of Principles of Natural Justice besides violation of Article 14, 21, 300-A of the Constitution of India and to consequently direct the respondents not to approve the Layout File NO.1013/0002/LP/KAD/2024 submitted by the 4th respondent herein, in the interest of justice;
