WHEREAS the Petitioner above named through their Advocate SRI K B RAMANNA DORA presented this Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or a direction declaring that

- (i) The action of the Respondents, more particularly, respondent No.3 to 15 in interfering with civil disputes and more extending threats to the Petitioners in respect of property of 6000 Sq.yds in Survey No.14/1 at Yendada, Chinagadili Mandal, Visakhapatnam without issuing any notice or furnishing information and following due process of law as illegal, unwarranted, unsustainable, arbitrary, unconstitutional, against Law as well as principles of natural justice.
- (ii) To quash FIR No.52/2026 for the offences under Section 318(3), 318 (4), 351 (2) r/w 3(5) BNS against the petitioners those proceedings are clear abuse of due process of law
- (iii) To declare that, the proceedings Rc.No.396/2026/SA-C dated.30.04.2026 of Respondent No.6 and search as well as Panchanama on 02.05.2026 to gather evidence for the purpose of Investigation by the respondents No.7 to 15 as wholly illegal, without jurisdiction, motivated, deliberate, unconstitutional, unwarranted, untenable, unsustainable, and in violation of Art 21 of Constitution of India and principles of natural justice,
- (iv) To direct the Respondents No.1 to 3 & 5 to take disciplinary action against the Respondents No.4, 6 to 15 for their misuse of powers under the Constitution of India and to harass the petitioners and senior citizens for their pecuniary benefits.
- (v) To conduct enquiry through independent authority of CBCID/CBI for illegal activities of the respondents in collusion with the 16th respondent and to harass the petitioners.

- (vi) To award damages of Rs. 1,00,00,000/- (Rupees one Crore only) for causing threat and mental harassment at the age of 87 and 82 years to the petitioners under the guise of registration and investigation of false case by colluding together by the respondents totally violating the Art 21 of Indian Constitution and provisions under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007.
- (vii) Not to interfere with the petitioners life and liberty without following due process of law and provide proper security and protection for peaceful life of the petitioners.
- (viii) To pay costs of the litigation.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri K B RAMANNA DORA Advocate for the Petitioner, GP for Home Department Respondent Nos. 1 to 4, GP for Revenue for Respondent Nos.5 & 6, directed issue of notice to the Unofficial Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
