Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to change the correspondent ship of the Velogode Junior College, Velogode (Kurnool) District A.P as such interference is against the judgment of this Hon'ble court in the case of S L Kameswari v/s Government Of Andhra Pradesh, Education Department, Hyderabad Citation- 1997 LawSuit (AP) 863 as the authority of removing the correspondent ship does not vest any power under the provision u/s 24(2) of Andhra Pradesh Education Act-1982, Pending disposal of WP No. 15849 of 2022, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and made herein and upon hearing the arguments of Sri JADA SRAVAN KUMAR Advocate for the Petitioner and GP FOR HIGHER EDUCATION for the Respondent Nos.1 to 6.

The Court made the following

ORDER:

"Heard the learned counsel for the petitioner and the learned Government Pleader for Higher Education appearing for the respondents. Perused the material available on record.

The grievance of the petitioner is that the petitioner is the correspondent of Velgode Junior College. As per the present Government Policy, the management of the college surrendered their grant-in-aid and all the aided staff working in grant-in-aid are surrendered to the Government. At present, the institution is being run as un-aided institution. Though, the petitioner institution is not getting any aid from the Government, the respondent authorities particularly the 5th respondent is making attempts to interfere into the affairs of the college and forcing the petitioner to quit from the post of correspondent of the college, at the instance of some political pressures.

The learned Government Pleader appearing for the respondents, on instructions submits that the respondents are not interfering into the affairs of the Velogode Junior College and the allegations made in this Writ Petition against the respondents are baseless.

Having considered the facts and circumstances of the case, in our view, the allegations made against the respondents will be considered in detail after filing counter affidavits by the respondents.

In the meanwhile, to protect the interest of the petitioner, the respondents are directed not to interfere into the affairs of the Velgode Junior College, Velgode, Kurnool District, Andhra Pradesh, till further orders."
