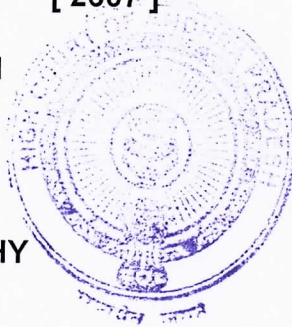

WHEREAS the Petitioners above named through their Advocate Sri CH.VIDYASAGAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction more particularly, one in the nature of WRIT OF MANDAMUS to declare the action of the 5<sup>th</sup> Respondent in making the illegal entries made in the revenue records in the name of 6<sup>th</sup> Respondent in the Adangals in respect of Ac.8-74 Cents in Survey No.563/5 situated at Mathrusree Anasuyamba Nagar in Nallapadu village, Guntur west Mandal, Guntur District on 05.01.2021 for the first time since 1970 where the land is no more an agricultural land, is illegal, arbitrary and un-Constitutional and consequently

a) direct the Respondent No.2 to 5, to delete entries made in the Adangals on 05-01-2021 on the name of the 6<sup>th</sup> Respondent and not to give any Pattadar Pass Book/ Title Deeds in respect of Respondents No.6 to 9 in Survey No.563/5 an extent of Ac.8-74 Cents situated at Mathrusree Anasuyamba Nagar in Nallapadu village, Guntur west Mandal, Guntur District.

b) direct the Respondents not enter our peaceful possession and enjoyment of our respective Plots No's 3, 4, 5, 6, 16, 7, 10, 32, 33, 34, 54,55, 60, 61, 70A, B, 94, 96 situated "Mathrusree Anasuyamba Nagar" in Survey No.563/5 an extent of Ac.8-74 Cents in Nallapadu village, Guntur West Mandal, Guntur District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri CH.Vidyasagar, Advocate for the Petitioners and GP for Revenue for the Respondent Nos.1 to 5, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
