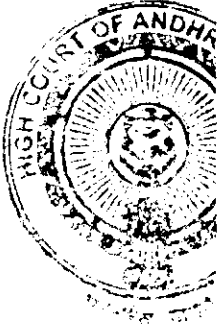

Post this case after four weeks."

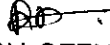
