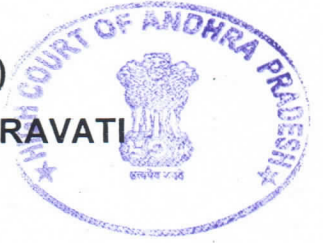

WHEREAS the Petitioner above named through her Advocate Sri Challa Hruday Raj, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of Writ of Habeas Corpus directing Respondents to produce the minor child, namely Aliya Fathima, before this Hon'ble Court and upon such production be pleased to restore the custody of the child to the Petitioner, declaring the illegal detention and forcible removal of the child by Respondent Nos.4 and 5 as arbitrary, illegal and violative of Article 21 of the Constitution of India.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Challa Hruday Raj, Advocate for the Petitioner, and of Advocate General for Respondent Nos. 1 to 3, directed issue of notice to the Respondent Nos. 4 & 5 herein to show cause as to why this WRIT PETITION should not be admitted.

are be and hereby directed to show cause on or before 21.05.2026 to which date the case stands posted either appearing in person or through an advocate as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to produce the minor child of the Petitioner, Aliya Fathima before this Hon'ble Court, Pending disposal of WP No.14470 of 2026, on the file of the High Court.

The Court made the following: ORDER

The present Writ of *Habeas Corpus* has been filed seeking custody of the minor child, namely, Aliya Fathima, who is the daughter of the petitioner and respondent No.4.

Learned counsel for the petitioner submits that the petitioner, being the natural mother of the minor child aged about 6 years, is entitled to the custody of her daughter.

Issue notice to respondent Nos.4 & 5.

Learned counsel for the petitioner is permitted to take out personal notice to the respondent Nos.4 & 5 by Registered Post and Acknowledgment Due and file proof of service in the Registry before the next date of listing.

Respondent No.3 is directed to secure the presence of respondent Nos.4 and 5 before this Court, along with the minor child, on 21.05.2026 for passing appropriate orders.
