Street, Rayadurg, Ananthapuram District, as illegal, arbitrary, violation of principles of Natural Justice, consequently direct the Respondents not to demolish/not to interfere into the petitioner's house property without following due process of law in Sy.No.213 an extent of 405 Sq.ft in land an extent of 133.33 Sq.Yrds situated in D.No.15-3-443/1, 15th ward, 3rd block in Rayadurgam Muncipal Limits, near Sri Uligamma Temple Street, Rayadurg, Ananthapuram District, forthwith.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Prakash C, Advocate for the Petitioner, and of GP for Revenue for Respondent Nos. 1 to 4, directed issue of notice to the Respondent Nos. 5 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.

Issue notice to respondent Nos. 5 to 7.

Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos. 5 to 7 through Registered Post Acknowledgment Due and file proof of service before the Registry by the next date of hearing.

Considering the entire facts and circumstances of the case, respondent Nos. 3 and 4 are directed not to demolish or interfere with

the house property of the petitioner, pending disposal of the writ petition, without following due process of law.
