Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ, Order or direction declaring the action of the Respondents in not re engaging services of the Petitioners in terms of Proceedings issued by the 5th Respondent vide Rc.No.1392113/APSS/A1/2021, dated 24.04.2026 and further trying to transfer them from their respective workplace without effecting the Minimum Time Scales as illegal, arbitrary and violative of Articles 14 and 21 of the Constitution of India and the guidelines in G.O.M's.No.24, Finance Department dated 18.02.2019, G.O.M's.No.40 Finance Department dated 18.05.2021 and G.O.M's.No.5 Finance Department dated 17.01.2022 and to consequently direct the Respondents forthwith renew the contracts in terms of the proceedings aforementioned and to implement Minimum Time Scale before effecting transfers.

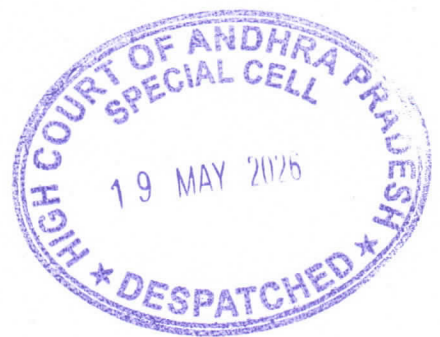
