Petition under Article 226 of the Constitution of India is filed praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of a writ of mandamus declaring the action of the respondents in proposing to demolish and remove part of our residential houses bearing door no. 2-70/2, 2-63/1, 2-64 and 2-66 situated at itampudi village, iragavaram mandal. West Godavari district, on the ground of alleged encroachment by issuing Lr. No. 696/itampudi/encroachments/2026 dt. 12.05.2026 without considering the explanation offered to the show cause notice, without conducting any survey and without affording opportunity of hearing as highly illegal, arbitrary and contrary to law besides violative of Art. 14, 19, and 300-A of the Constitution of India and consequently direct the respondents not to demolish the said houses by setting aside the impugned proceedings dt. 12.05.2026.

**IA NO: 1 OF 2026**

Petition under Section 151 CPC is filed praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents 2 to 6, not to demolish the houses bearing door no. 2-70/2, 2-63/1, 2-64 and 2-66 situated at Itampudi Village, iragavaram Mandal, West Godavari District, Andhra Pradesh, Pending disposal of WP 14528 of 2026, on the file of the High Court.

The petition/Appeal coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of SRI YASWANTH GADE Advocate for the Petitioner(s), GP FOR ROADS BUILDINGS for the Respondent Nos.1 to 4, GP for Revenue for Respondent No. 5, Sri Y.Koteswara Rao, Standing Counsel for ZPPS, MPPS and Grama Panchayats for Respondent No.6 and the Court made the following.

**ORDER**

**“Heard Sri Yaswanth Gade, learned Senior Counsel appearing on behalf of the petitioners; the learned Assistant Government Pleader for Roads and Buildings appearing for respondent Nos. 1 to 4; and the learned Assistant Government Pleader for Revenue appearing for respondent No. 5.**

Considering the entire facts and circumstances of the case, respondent Nos. 2 to 6 are directed not to demolish the houses of the petitioners, pending disposal of the writ petition, without following due process of law.
