Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the inaction on the part of the respondents 2 to 5 in not issuing Pattadar Pass Books in the names of 139 members of the petitioner's Society though the Pattadar Pass Books issued in the names of 66 members of the Society, in an extent of Ac.0- 50 Cents for each pattadar, out of an extent of Ac.1 10.00 Cents out of the total extent of Ac.474.00 Cents situated in R.S.No.146 of Tatapudilanka, Kapileswarapuram Mandal, East Godavari District, despite several requests and demands made by tYc petitioner and the written representations dt.4.2.2019 and 16.5.2019, is illegal, arbitrary, unlawful and unreasonable and in violation of Principles of Natural Justice and Fundamental Rights of the petitioner under Article 300-A of the Constitution of India and by consequently directing the respondents 2 to 5 to issue pattadar pass books in the names of 139 members of the petitioner's Society, in an extent of Ac.0-50 Cents for each pattadar, out of an extent of Ac.110.00 Cents out of the total extent of Ac.474.00 Cents situated in R.S.No.146 of Tatapucrilanka, Kapileswarapuram Mandal, East Godavari District,
