WHEREAS the Petitioner above named through their Advocate Sri A V S Laxmi presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any Writ, order or direction more especially one in the nature of WRIT OF MANDAMUS, declaring the merit list and admissions pursuant to Notification No.20 dated August 26, 2021 published in the Andhra Pradesh Gazette, regarding APRCET-2021, Ph.D Admission Test for admissions into the Ph.D programme in all the Universities in the State of Andhra Pradesh, as illegal, arbitrary, without jurisdiction, unconstitutional, violative of 14 and 21 of the Constitution and consequently nullify the entire process and order enquiry and initiation of action against all the concerned for the illegal admission process, direct readmission process in terms of law or in the

alternative direct issuance of admissions to the petitioners who are qualified and eligible in terms of law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri A.V.S. Laxmi Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
