Petition under Article 226 of the Constitution of India is filed, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondents mutating the names of the 6th AND 7th respondents in revenue records in respect of land in Sy.No 181a, 181a2 AND 182-1 to an extent of Ac 2.6300 cents, Ac 1.2000 cents AND Ac 1.3000 cents respectively out of land in Sy No. 181-1 c and 182-1A an extent of Ac 7.67 cents, Ac 2.60 cents respectively situated at Jaddangi Village, Rajavommangi Mandal, A.S.R District (erst while East Godavari District) is bad, arbitrary, contrary to the provisions of Andhra Pradesh Scheduled Areas Land Transfer Regulation, 1/1959 as amended and also offends. Arts. 14, 21 AND 300-A, 342 of the Constitution of India.

Petition under Section 151 CPC is filed, praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents to delete the names of 6th and 7th respondents revenue records Sy.No 181a, 181a2 & 182-1 to an extent of Ac 2.6300 cents, Ac 1.2000 cents & Ac 1.3000 cents respectively and restore the same in favour of the petitioner situated at Jaddangi Village, Rajavommangi Mandal, A.S.R District (erst while East Godavari District), in the interests of justice and fair play., Pending disposal of WP 15075 of 2026, on the file of the High Court.
