WHEREAS the Petitioner above named through her Advocate Sri THOPURI AJAY KUMAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the Nature of Writ of Mandamus, to declare the inaction of the respondents in Enhancing the age of superannuation for 60 to 62 years by Regularizing the service of the petitioner is illegal arbitrary violative of Article 14 19 and 21 of the constitution of India and contrary to the binding Government Orders., G.O.Ms.No.114 dated 21.10.2023, G.O.Ms.No.15 dated 31.01.2022, G.O.Ms.No.37 dated 29.01.2024 and Consequently direct the respondents to Enhance the age of Superannuation of the petitioners from 60 to 62 by Regularizing the services of the petitioners in terms of G.O.Ms.No. 114 dated 21.10.2023;
