Authorities, especially Respondent No. 3 and 4 in allowing Respondent No.5 to contemplate to dispossess evict the petitioner from his BN -12 Quarter situated within Sainik School, Korukonda Campus and also in allowing Respondent No.5 to ultra viresly issue impugned Re-allotment Order vide No. SSK/3015/ACCN/QM/2025 dated 14.05.2026 impugned Show-cause Notice vide No. SSK 3015 ACCN/QM/2026 dated 25.05.2026 as well as impugned Vacation of BN-12 Quarter Notices vide SSK/3015/ACCN/QM/2025 dated 25.05.2026 and 29.05.2026 without considering the Representations Replies dated 23.05.2026, 26.05.2026 and 29.05.2026 as ultra vires, illegal colourable exercise of powers, arbitrary, nonapplication of mind, withouthaving any jurisdiction violation of Section 3 of the Public Premises (Eviction of Unauthorised Occupants) Act 1971 violation of principles of natural justice violation of Articles 14 and 21 of the Constitution of India and consequently set aside the same
