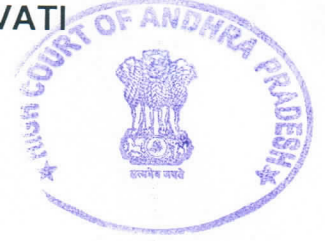

WHEREAS the Petitioner above named through his Advocate Sri. PASALAPUDI SATYA HARITHA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the endorsement in Lr.No.AE/O/D.Tirumula/ F.Dock/D.No.157/26 dated 26.05.2026 issued by the Respondent No.3 thereby proposing to lay an electricity line in and adjoining petitioners landed property admeasuring an extent of Ac.1.30 cents covered by S.No.231/3 situated in Venkatakrishnapuram Revenue Village of Dwaraka Tirumala Mandal in Eluru District, without adhering to and complying with the order dated 05.05.2025 passed by this Honble Court in W.P. No.11891 of 2025 as illegal, irregular, irrational, violative of principles of natural justice, violative of provisions of The Electricity Act, 2003 and rules and Regulations framed there under and offends Articles 14, 21 and 300A of Constitution of India and consequently direct the respondents not to form electrical line along with poles abutting the said lands of petitioner

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri PASALAPUDI SATYA HARITHA Advocate for the Petitioner, and of GP for Energy for respondent No.1, Sri V.V.Satish, SC for APEPDCL for respondent Nos. 2 to 7, directed issue of notice to the Respondent No. 8 herein to show cause as to why this WRIT PETITION should not be admitted.
