Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the respondents in marking the petitioners RCC residential and commercial buildings for demolition for the proposed widening of the Nh-167B in Ward No.2 covered by Sy.No. 370 of Pamuru Town and Mandal, Markapur District.,(erstwhile Prakasam District) without issuing any and without following the mandatory procedure under Sections 4, 5, 6, 7, 11, 19, 21,26 to 30 and 31 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 as illegal, arbitrary, unconstitutional and violative of Articles 14, 21 and 300A of the Constitution of India and consequently direct the respondents not to take any coercive steps including demolition or eviction against the petitioners properties and buildings without following due process of law and pass

::ORDER ::

The petitioners, 34 in number, have filed the present writ petition challenging the high-handed action of the respondent No.3 in making markings on their properties admeasuring 47.11 yards; 106.66 yards; 33.33 yards; 105 yards; 26.66 yards; 33.33 yards; 58.33 yards; 70 yards; 60 yards; 122.22 yards; 133.33 yards; 97.77 yards; 46.66 yards; 222.22 yards; 53.33 yards; 9.33 yards; 43.33 yards; 26.66 yards; 31.11 yards; 56.22 yards; 100 yards; 133 yards; 100 yards; 22.22 yards; 22.22 yards; 45.33 yards; 75 yards; 61.33 yards; 194.44 yards; 23 yards; 60 yards; 33.33 yards; 17.77 yards and 87.11 yards situated in Sy.No.370, Ward No.2 of Pamuru Town and Mandal, Markapur District, without issuing any notice or following the procedure contemplated under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, as illegal and arbitrary.

2. Heard Sri Pavan Kumar Pasupuleti, learned counsel for the petitioners, Sri Panuku Rajesh Kumar, learned Assistant Government Pleader for Panchayat Raj appeared for respondent No.1, Sri M. Chandra Sekhar, learned Assistant Government Pleader for Revenue appeared for respondents 2, 5 to 8, Ms. Kavitha, learned counsel representing Sri M. Sudhir, learned Standing Counsel appeared for respondents 3 & 4 and Sri T. Niranjana, learned Deputy Solicitor General of India appeared for respondent No.9.

3. The writ petition was listed on 04.06.2026. Sri Bhagat Singh, learned Assistant Government Pleader for Revenue, on written instructions, submitted that the revenue authorities did not make any markings on the aforementioned structures of the petitioners. Hence, the writ petition was adjourned at the request of the learned Counsel appearing for the Gram Panchayat to get written instructions.

4. Today, when the matter is taken up, Ms. Kavitha, learned counsel representing Sri M. Sudhir, learned Standing Counsel appearing for respondents 3 & 4, on written instructions, would submit that the authorities of the Gram Panchayat are not interfering with the petitioners' possession and enjoyment of the properties situated in Sy.No.370, Ward No.2 of Pamuru Town and Mandal, Markapur District. The instructions are made as part of the record.

5. Given the facts and circumstances of the case, keeping the writ petition pending, inviting a counter-affidavit will not serve any purpose. Hence, the Writ Petition is disposed of at the stage of admission with the consent of learned counsel appearing on either side, directing the respondents 3, 4 & 6 not to interfere with the aforementioned properties situated in Sy.No.370, Ward No.2 of Pamuru Town and Mandal, Markapur District, without following due procedure. No order as to costs.

As a sequel, pending miscellaneous petitions, if any, shall stand closed.
