VIJAYADITYA REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, preferably one in the nature of a Writ of Mandamus, to declare the action of Respondent No.3 in trying to evict petitioner No.1 from land situated in Sy.Nos.1170,1171- 1,1174-1,1174- 2 and 1176-3, 1154/3, 1156/1, 1156/2 and 1157/1 to an extent of Ac.6.07 cents , petitioner No.2 from land situated in Sy.No.1170 to an extent of Ac. 1.79 cents, petitioner No.3 from land situated in Sy.No.1172-A to an extent of Ac.2.00cents, petitioner No.4 from land situated in Sy.No.1170/1 to an extent of Ac.1.79 cents, petitioner No.5 from land situated in Sy.No.1170/A and 1183-1A to an extent of Ac.2.94 cents and petitioner No.6 from land situated in Sy.No. 1170 to an extent of Ac.2.00 cents in Kovur Village and Mandal, Nellore District as illegal, arbitrary, unsustainable, unconstitutional, contrary to provisions of Section 55 of Waqf Act, 1955 and consequently direct the respondents not to interfere with peaceful possession of petitioner No.1 from land situated in Sy.Nos.1170,1171-1,1174- 1,1174-2 and 1176-3, 1154/3, 1156/1, 1156/2 and 1157/1 to an extent of Ac.6.07 cents , petitioner No.2 from land situated in Sy.No.1170 to an extent of Ac.1.79 cents, petitioner No.3 from land situated in Sy.No.1172-A to an extent of Ac.2.00cents, petitioner No.4 from land situated

in Sy.No.1170/1 to an extent of Ac.1.79 cents, petitioner No.5 from land situated in Sy.No.1170/A and .1183-IA to an extent of Ac.2.94 cents and petitioner No.6 from land situated in Sy.No.1170 to an extent of Ac.2.00 cents in Kovur Village and Mandal, Nellore District

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri M.V.
