WHEREAS the Petitioner above named through his Advocate Sri Parvataneni Satish Kumar, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction more particularly one in the nature of Writ of Mandamus declaring the deliberate action of the 4th respondent in issuing the impugned notice dated 18-05-2026, under Rule 3 of the Andhra Pradesh Assigned lands (Prohibition of Transfers) Rules - 2007 with respect to subject agricultural land Adm. Ac 2.59cents in survey no 118-1 of Pangidigudem Village, Dwaraka Tirumala Mandal, Eluru District (Erst while West Godavari District) is contrary to the 4th respondents own admittance of issuance of DKT Patta L.D.No:45/1417 dated 10-03-2008 in the counter filed in WP 20106 of 2020 as illegal, arbitrary and in violation of the principles of natural justice as well as article 14, 16 300-A of the Constitution of India.

Consequently, set aside the impugned notice dated 18-05-2026, issued under Rule 3 of the Andhra Pradesh Assigned lands (Prohibition of Transfers) Rules-2007 in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Parvataneni Satish Kumar, Advocate for the Petitioner, and of GP for Revenue for Respondent Nos. 1 to 4, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.
