WHEREAS the Petitioner above named through his Advocate SRI SURESH KUMAR REDDY KALAVA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a WRIT OF MANDAMUS declaring the action of the Respondents herein particularly Respondent Nos. 5 to 7 in threatening to disconnect the Petitioners power service connection vide USC.No. 5213405005146 with respect to the petitioners ground nut mill (Madeena Mills) situated at Sy.No.1003/A1 in an extent of Ac. 0.25 cents of Chinnathippasamudram Village (CTM), Madanapalle Mandal, Annamayya District, Erstwhile Chittoor District at the instance of Respondent No.8, without issuing any notice or following due process of law, despite paying the electricity charges without fail, as nothing but illegal, arbitrary, highhanded and violation of principles of natural justice apart from violation of Articles 14, 19, 21 and 300-A of The Constitution of India and consequently direct the respondents not to disconnect the petitioners power connection vide USC.No. 5213405005146 with respect to petitioners ground nut mill (Madeena Mills) situated at Sy.No.1003/A1 in an extent of Ac. 0.25 cents of Chinnathippasamudram Village (CTM), Madanapalle Mandal, Annamayya District, Erstwhile Chittoor District.,

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri SURESH KUMAR REDDY KALAVA Advocate for the Petitioners, GP FOR ENERGY for respondentNo.1, Sri Kota Venkata Rama Rao, Standing Counsel for
